### A Word from our President

News about our club elections (November 5th) from the Social Club Board of Directors, and questions for Sewing Etc Club members:

- Each club shall, as necessary, hold their annual elections one of 3 ways as determined by the club board (Zoom, email, in person).

The board has not decided this yet. **What do you think?**

- a quorum must decide the outcome. This will be the majority of the participants. (not the majority of the club members)

Example: a club sends out 100 emails and gets 50 responses, then 26 equals a majority.

- a club may elect to roll over individual annual membership dues from 2020 to 2021. (we already voted to do this.)

- the Social Club Board does NOT recommend reimbursement of 2020 club dues if requested by the membership. However, it should be noted that each club will still be responsible for the \$.25 membership fee due to the Social Club Board for fixed costs (like insurance, taxes, 1099 preparation and audit). The \$.25 fee will be waived for the remainder of 2020, but will continue as usual in January 2021, whether or not clubs will be able to meet due to COVID 19. The Social Club Board's costs are fixed and need to be paid either way.

Nominations for Sewing Club Board:

I do not have confirmation from existing Board members as to their desired to continue on the Board. However, if you are interested in helping the club in this manner, **please let me know**. I'd like to have a proposed slate for 2021 by the September (9/3) meeting. Board positions are President, Vice-president, Treasurer, Secretary.
